The amount of Rs. 8,34,84,694/- (Rupees eight crore thirty four lakh eighty four thousand six hundred ninety four only) will be credited to the account of State Government of Mizoram through the Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M.No.F-II(45/76/SC) dated 22.02.1977.
5. No Utilization Certificate is required as the above release of funds is reimbursement of expenditure already incurred for execution of the project under NERUDP.
6. Concurrence of Finance Division has been obtained vide their Dy No.630/US(D-5)/FD/14 dated 22.05.2014.
7. This Sanction has been registered at Sl.No. 1/Mizoram/2014-15 of the Sanction Register of NERUDP Section for the year 2014-15. for Tranche-II.
